Promotion and recognition

More strategic and co-ordinated efforts are needed to make youth work better understood, visible, and credible as a distinct work arena.

Possible concrete measures:

- Events and targeted campaigns
- Showcase the impact of youth work on communities and societies
- Co-operate with organisations that have developed tools to support recognition
- Build on and learn from initiatives that showcase higher education structures engaging with youth work

Innovation and emerging challenges

To be a safety net for all young people in times of uncertainty, more resilient youth work structures are required based on long-term thinking, reflexivity, and strategy-based youth work.

Possible concrete measures:

- Support actions for the safety and mental health of young people
- Improve smart youth work through competence development
- Make youth work greener
- Support young people's engagement in a democratic society
- Create innovation hubs for progressive and pioneering youth work

Policy frameworks

Youth work should be an integral part of youth policy, systematically incorporating the needs of and measures relating to youth work into youth policies, vertically and horizontally.

- Support involvement of young people and youth workers in policy-making
- Promote youth laws, youth work laws, and strategies for youth work
- Further develop working methods that involve young people as equal creators of the policy affecting them

Priority addressing the European institutions to further align their visions for youth work within their respective strategies to even better support the growth of youth work throughout Europe

- Establish national working groups
- Provide framing conditions for supporting local youth work provision
- Establish a robust communications and networking strategy
- Anchor ownership for the Bonn Process in the whole youth work community of practice
